Ingestion.

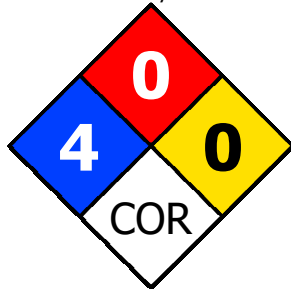
