Ingestion.

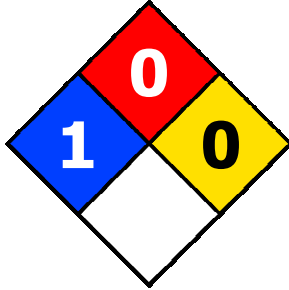
