## **Inhalation.**

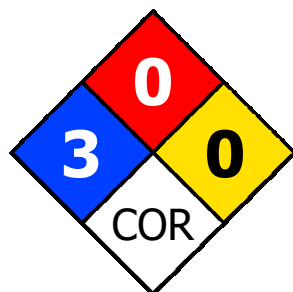
